A CF 5523, or equivalent format, should be used for all footwear unless the commercial invoice shows (a) gender (male, female, unisex), (b) upper is all leather exclusive of linings, and the sole is cemented to the upper.

Items 1 and 2 — Self explanatory

Item 3 — Type of Shoe

- a. Boot, protective against water, chemicals, or cold or inclement weather
- b. Boot, ski
- c. Boot, other than protective or ski
- d. Bootie, knit, for infants
- e. Disposable, not rubber or plastic
- f. Moccasin, soled
- g. Moccasin, unsoled
- h. Protective against water, chemicals, or cold or inclement weather, other than boot
- i. Skate shoe
- j. Zori
- k. Other (describe in exact commercial terms)

Items 4, 5, and 6 — Self explanatory

Item 7 — Method of Construction

- a. Stitched — Turned
- b. Stitched — Welt
- c. Stitched — Other
- d. Cement
- e. Other (specify)

Item 8 — Kind of Construction

- a. Shell molded bottom - cup sole - cemented and/or stitched to upper
- b. Unit molded bottom cemented to upper
- c. Rolled sole
- d. Sole simultaneously molded and attached to upper (simultaneous injection)
- e. Vulcanized
- f. Riveted
- g. Exclusively adhesive
- h. Combination of the above (specify)
